

# CALL FOR GRANT APPLICATIONS (AE2025-0004)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) within the scope of the ATE funded by IAPMEI with reference 56 Co-financed by Component 5 - Capitalization and Business Innovation, integrated in the Resilience Dimension of the Recovery and Resilience Plan within the scope of the Recovery and Resilience Mechanism (MRR) of the European Union (EU), framed in the Next Generation EU, for the period 2021 - 2026.

## **1. GRANT DESCRIPTION**

Type of grant: Research Grant (BI)

General scientific area: ENGINEERING

Scientific subarea: Mechanical engineering

Area of Work: Integration of thermal storage systems in the commercial sector

Grant duration: 9 months 27 days, starting on 2025-03-05.

Scientific advisor: Zenaida Mourão

Workplace: INESC TEC, Porto, Portugal

Maintenance stipend: € 990,98 or 1259,64, according to the table of monthly maintenance stipend for FCT grants , paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

INESC TEC supports costs with registration, enrolment or tuition fees, during the grant duration, under the terms established in the internal document: "Payment of Tuition fees to grant holders".

The grant holder will benefit from health insurance, supported by INESC TEC.

#### 2. OBJECTIVES:

The objectives of this work are the following: Characterization of the thermal energy profile of the building and the consumption profile of the systems associated with tertiary cold production for the quantification of the flexibility potential. Development of a planning system for the integration of thermal storage, based on PCM, in tertiary buildings, in the management of cold systems, as well as in the reduction of energy losses arising from logistics operations. Development of a predictive optimization module for cooling systems equipped with PCM systems to support demand management.

# 3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

- Characterization of the energy consumption profiles of the cooling systems with and without PCM storage,
- Development of a model for the charging and discharging of the PCM storage system,

- Development of an energy management system model for the cooling system with PCMs, aiming to define the charging and discharging periods for the PCM storage system according to specific operational goals (e.g., energy savings, lower GHG emissions, increased self-consumption),

Prepare a scientific report on activities and write scientific articles.

## 4. REQUIRED PROFILE:

#### Admission requirements:

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

## Preference factors:

- Experience in thermal energy modelling of buildings.

- Experience in modelling thermal storage systems, specifically phase change materials (PCM), in tertiary buildings.

- Experience in the application and evaluation of predictive optimization modules.

## Minimum requirements:

- Ability to develop models for thermal storage management in buildings.
- Knowledge of optimization models in the context of energy systems.
- Knowledge of phase change materials (PCM) and their application in cooling systems.
- Knowledge of programming (e.g., Python).
- Fluency in English (written and spoken).

# 5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

**Selection criteria and corresponding valuation:** the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 50%), Scientific Publications (PC, 10%), Experience (EX, 30%) and Motivation Letter (CM, 10%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (90%) and EI (10%).

# **DISABILITY INCENTIVE**

Candidates who present a degree of disability equal to or greater than 90% will benefit from an incentive (20) in the score of the CV Assessment.

Candidates who present a degree of disability equal to or greater than 60% and less than 90% will also benefit from an incentive (10) in the score of the CV Assessment.

Said score may, in these cases, exceed 100 points.

Candidates must demonstrate the degree of disability during the application, namely through the submission of the Multi-Purpose Medical Certificate of Disability, issued in accordance with Decree-Law no. 202/96, of October 23 - currently in effect.

Candidates must declare, in the application form, the type of disability used throughout the selection process, in order to proceed with the required adaptations.

- 1. Motivation letter;
- 2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
- 3. Certificate or diploma degree;
- Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
  The proof of enrollment may be presented just during the grant hiring stage.
- 5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
- Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
- 7. Other supporting documents relevant to the final assessment.

Failure to deliver the required documents within the 90-day period after the date of the notice of the conditional awarding of the grant implies its cancellation.

**Submission of applications:** the application will be formalised by submitting the form available in the *Work With Us* section of INESC TEC website.

# 7. BINDING LEGISLATION AND REGULATION
